



What the Bible Says About Homosexuality

Leviticus 18:22, "You shall not lie with a male as with a woman. It *is* an abomination."

Leviticus 20:13, "If a man lies with a male as he lies with a woman, both of them have committed an abomination. They shall surely be put to death. Their blood *shall* be upon them."

Fornication who are not

μοιχός moichós; "unfaithfulness to a covenant;" spiritually this refers to those unfaithful to God; sexually this refers to those who are married and engage in sex with someone to whom they are not married.

- Homosexuality is normal, healthy, and desirable
 - Romans 1:24–32
 - Every human being is distorted, warped by the Fall
 - Just because it feels "right" doesn't make it right
 - Homosexuality is not natural or normal

- Homosexuality is normal, healthy, and desirable
 - In 1973, due to pressure from the Gay Rights Movement, the APA declassified homosexuality as a mental disorder.
 - Preceded by 3 years of protests, disruptions, and chaos
 - Intimidation ruled
 - Only 25% of the members voted, 58% in favor of removal

Homosexuality is normal, healthy, and desirable

"Militant homosexual groups continued to attack any psychiatrist or psychoanalyst who dared to present his findings as to the psychopathology"

This decision was "the medical hoax of the century."

Homosexuality is normal, healthy, and desirable

1977:

10,000 members polled at random

69% said homosexuality is a pathological adaptation

18% disagreed

13% uncertain

- Homosexuality is normal, healthy, and desirable
 - Only 10% are "relatively monogamous" or "relatively less promiscuous", Institute for Sex Research
 - 60% have more than 250 lifetime sex partners
 - 28% have more than 1,000 lifetime sex partners
 - 79% admit that more than half are strangers
 - Lesbians are less promiscuous than men, but more volatile and unstable

Homosexuality is normal, healthy, and desirable

The Bible:

- Any sexual activity outside of marriage is fornication and sin.
- 44 references to fornication in the Bible in the context of sin.
- Homosexuality is never mentioned in a positive context.

"If homosexuality is a perversion of what is natural, then homosexuals must look at their own conduct in an entirely different light and explain it in less satisfying terms."

- Homosexuals are born that way
 - No evidence of a "gay gene" if inherited, it would have died out
 - 1991 study by Dr. Simon Levay
 - Flawed study
 - Twin studies

Homosexuals are born that way

"The genetic theory of homosexuality has been generally discarded today."

Homosexuals are born that way

"The idea that people are born into one type of sexual behavior is entirely foolish . . . Homosexuality is a behavior, not a condition, and something that some people can and do change, just like they sometimes change other tastes and personality traits."

Observations on the Twin Studies

1991 Study by Bailey and Pillard

Self-admitted methodological flaws subjects recruited through advertisements in homosexual periodicals

In Dec 2014 findings from 8 major twin studies in Australia, the U.S.and Scandinavia over the last twenty years concur: gays were not born that way.

If genetics were the determinate, then the results would need to be 100% concordance.

"There is no consensus among scientists about the exact reasons that an individual develops a heterosexual, bisexual, gay, or lesbian orientation. Although much research has examined the possible genetic, hormonal, developmental, social, and cultural influences on sexual orientation, no findings have emerged that permit scientists to conclude that sexual orientation is determined by any particular factor or factors. Many think that nature and nurture both play complex roles ..."

Homosexuals make up 10% of the population.

USA Today: 25 million Washington Times: 10% of men, 5% of women

American Psychiatric Association: 10%

- Homosexuals make up 10% of the population.
 - Figure derives from a 1948 study by William Kinsey
 - 25% of the 5,300 studied were prison inmates (44% had homosexual relations in prison)
 - Several hundred male prostitutes were in the study

Homosexuals make up 10% of the population.

Misrepresented numbers:

10% of white males were more or less exclusively homosexual for at least 3 years between 16 and 65.

Homosexuals make up 10% of the population.

Forman study, 1984-1988: 1.7%

Univ of Chicago, 1989: "less than 1% are exclusively homosexual"

Based on the 2013 NHIS data [collected in 2013 from 34,557 adults aged 18 and over], 96.6% of adults identified as straight, 1.6% identified as gay or lesbian, and 0.7% identified as bisexual. The remaining 1.1% of adults identified as "something else" [0.2%,] stated "I don't know the answer" [0.4%] or refused to provide an answer [0.6%].

More specifically, 1.8 percent of men self-identify as gay and 0.4 percent as bisexual, and 1.5 percent of women self-identify as lesbian and 0.9 percent as bisexual.

Why Same Sex Relationships Are Wrong:

- They are an attempt to meet legitimate needs (for acceptance, approval and affection) in illegitimate, ungodly ways.
- They are outside God's created intention for sex:

 the complementarity of male and female physically, emotionally, spiritually.
- Marriage is an earthbound illustration of Christ and the church—the unity of two different entities.

Why Same Sex Relationships Are Wrong:

- They are idolatrous: Romans 1, worship of the creature (sex or the sexual partner) instead of the Creator.
- They are destructive and dangerous
- "A façade of normalcy"

Committed relationship = faithful and stable

- Men: 3-5 outside partners (USA) - 8 (Holland)
- >5 years, not one monogamous relationship
- Lesbian relationships: very volatile; domestic and emotional violence

"Monogamy is not a word the gay community uses We talk about fidelity. That means you live in a loving, caring, honest relationship with your partner. Because we can't marry, we have people with widely varying opinions as to what that means. Some would say that committed couples could have multiple sexual partners as long as there's no deception. Each couple has to decide."

- AIDS
- Much higher risk of STDs
- 3x rate of alcoholism and drug abuse

- Shortened lifespan

Marriage is the best possible place for children

Puts kids at risk

Isaiah 5:20, "Woe to those who call evil good, and good evil; Who put darkness for light, and light for darkness; Who put bitter for sweet, and sweet for bitter!"

Can a Homosexual be Saved?

- Homosexuality is not an issue in salvation
- If you're not saved, the issue is believe on Jesus Christ.
- If you are saved, the issue is learning to walk by the Spirit.
- All Christians struggle with "sins that easily beset us," Heb. 12:1
- Christians can be bigots, adulterers, liars, thieves, and murderers

First Amendment

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise there of" (italics added).



The Challenge: Free Expression of Religion

Justice Scalia pointed out that the majority decision emphasized that the decision would not impact the right of believers to continue to "advocate" and "teach" their views of marriage. But the First Amendment guarantees the free "exercise" of religion, and that, he points out, is a word the court "ominously" did not use.

What Can Christians Do?

- Pray for your leaders and for your nation.
 Tim. 2:1–4
- 2. Learn the facts, know what the Bible says, know what the history of the US is, and know the myths about homosexuality. Hosea 4:6
- 3. Do not lose hope (1 Pet. 3:15; Lam. 3:21; Titus 2:13).
