



Is Climate in Histories of the Nations?



Climate Changes from Historical Records


- **200 B.C. to A.D. 500 Roman “warm period”**

Climate Changes from "Proxy" Data




Suppressing the Medieval Warm Period (MWP)




Framework Scheme – Gen 1-11

Two levels of existence: Eternal self-determining personal God & Temporal dependent creation




~~**One level of existence: Impersonal Nature**~~




God determines the relative values of man & nature; Nature is not to be 'divinized'

Man is to have dominion over all of terrestrial nature to bring forth its beauty and productivity








Implications of the fall on man and nature



Implications of the Exodus & Mt. Sinai on human cultural behavior

Stephen Schneider said: “we have to offer up some scary scenarios, make simplified, dramatic statements and [make] little mention of any doubts we might have.”

Email to Dr. Deming: “We have to get rid of the Medieval Warm Period”; “Revised data sets” by Michael Mann and NOAA

James Lovelock: “As an independent and loner I do not mind saying, alright, I made a mistake. . . .A university or government scientist might fear an admission of a mistake would lead to the loss of funding.”

Implications of the Exodus & Mt. Sinai on human cultural behavior

Climategate 2009: “The emails reveal that the world’s leading climate scientists were working together to block Freedom of Information requests to review their data; marginalize dissenting scientists; manipulate the peer-review process; and obscure, massage, or delete inconvenient temperature readings. . .”

Baliunas-Soon paper (2003) & Mann’s email: “Perhaps we should encourage our colleagues in the climate research community to no longer submit to, or cite papers in, this journal. We would also need to consider what we tell or request of our more reasonable colleagues who currently sit on the editorial board.”

“Post-Normal Science”

“A new concept of science was introduced by Funtowicz and Ravetz during the 1990s . . . The exercise of scholarly activities is defined by the dominance of goal orientation where scientific goals are controlled by political or societal actors In post-normal science, the maintenance and enhancement of quality, rather than the establishment of factual knowledge, is the key task of scientists Scientists have to contribute to society by learning as quickly as possible about different perceptions . . . instead of seeking deep ultimate knowledge.”

Biblical response to abuses of the environment:

The 8th commandment: classify it as “theft” and demand restitution by the offending person or corporation or *government agency*.

We of God’s counter-culture must courageously oppose the paganizing culture of deceit that is destroying the biblical influence on Western civilization by prayer, public debate and living out our faith whether in business, the educational establishment, academia, or the media.

Three forces are at work in the climate crisis phenomenon: (1) revived pagan re-divinization of nature over man; (2) corruptibility of federal funding of science research; and (3) ambitious globalist politicians.

The biblical framework brings special revelation into full contact with general revelation: (1) Creation rejects nature-worship, leaving nature “pristine,” and Malthusian math; (2) the Fall explains fear of a climate apocalypse and how man’s sin brings God’s judgment upon nature; (3) the Flood & Covenant constrain geophysical nature; (4) Call of Abraham, Exodus & Mt. Sinai establish a counter-culture’s ethical norms against the pagan framework .

Sin → Rejection of the Word of God's exposing Light

Resulting deception → construction of a pagan framework, Babellesque politics, and an eschatology of a pagan utopia

Resulting corruption of science → growing distrust of its reliability for decision-making

Solution: extend the Word of God into the culture fulfilling the role of God's counter-culture
